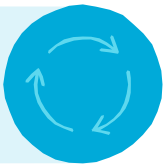
Often unfairly seen as a 'boring' job, accountancy is in fact a diverse career with unlimited potential for progression and change.

However, most accountants today use spreadsheets or accounting software to do a lot of the calculations and processes. So you certainly don't need to be a maths or IT genius!



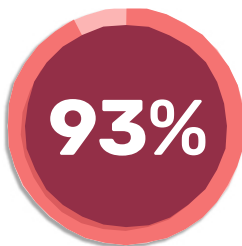
